



# Wyoming Delta Dental Foundation Wyoming Smiles Senior Dental Program - 2025

The Wyoming Smiles Senior Dental program is a FREE dental insurance plan for Wyoming seniors who meet income and program qualifications.

The program is sponsored by the Wyoming Delta Dental Foundation.

To qualify for the program, individuals must:

- Be a resident of Wyoming, living in Wyoming.
- Be age 65+.
- Cannot be covered by any dental insurance (Medicare or insurance purchased on your own) or be provided free dental coverage by other programs.
- Have a combined household income within the range shown in the income chart.
- Submit Proof of Income (Social Security Award letter or 2023 taxes or paystubs). [Proof of Income MUST be Submitted with the application.](#)
- Be able to travel to a dental office for treatment within 90 days of being accepted into the program (or show proof of treatment prior to being in the program).

Household size is defined as you, your spouse or any dependent children.

Gross income is your total income before taxes or deductions. Please report your gross income. Your income includes your Social Security even if it is not included on your taxes.

Please send a copy of the first page of the most recent tax return for your household.

If your household does not file taxes, please provide documentation showing your annual total household income such as:

- Social security award letters
- A copy of your most recent W-2 forms
- Pension statements, interest statements, etc.

## 2025 Program Details

In 2025, there will be THREE programs available:

Senior Plus Plan – provides coverage for seniors who are new to the program or have been on for one previous year. This plan covers a range of dental benefits (see services covered) including preventive, basic and major services up to \$1,500.

Senior Basic Plan – provides coverage for seniors who have been on the WY Smiles Senior Dental program previously for two or more years. This plan covers a range of dental benefits (see services covered) including preventive, basic and major services up to \$1,000.

Senior Denture Plan – provides coverage for those seniors with existing dentures, up to \$500.

The WY Delta Dental Foundation will determine which program an eligible senior will be enrolled in. Program placement will be based on whether the senior has been enrolled previously in the program, the length of previous enrollment as well as denture status.

*In addition to the above, there will also be availability for a limited number of eligible seniors on the Plus or Basic plan to receive a full denture set (if needed) during 2025.*

The Denture funding availability will be on a first come first serve basis based on claims received. A Pre-Determination must be submitted by your dentist. If a pre-determination is not submitted & authorized, the dentures will not be covered under the denture program and will be subject to the annual maximum.

### Next Steps:

- We will review your application and let you know whether you have been accepted into this year's program.
- The Wyoming Smiles Senior Dental program has a limited number of spaces available each year for eligible seniors. Eligibility is on a first come, first serve basis. Once all available spaces are filled, a waiting list will be developed.
- If you are accepted into the program, we will send you information on how to find a dentist and get started.
- The information in this brochure is valid October 1, 2024 – May 1, 2025, however the benefit year for those accepted is January 1, 2025 – December 31, 2025.
